Following the arrest on 26<sup>th</sup> July 2016, the suspects were grilled for hours first in Enugu by Criminal Investigation Department (CID) of Enugu State and thereafter, they were handed over to the Special Fraud Unit (SFU), Milverton Avenue, Ikoyi, Lagos on 27<sup>th</sup> July 2016 for further investigations.

The Muddenahalli Group applied all their force and global contacts to influence the investigation, but to no avail. As Sathya Sai Baba has said- THE TRUTH SHALL PREVAIL.

After following due protocols and procedures involved in dealing with Foreign Nationals, the suspects, except those who are resident of Nigeria, i.e., Anant Rao and Ashok Pai, were handed over to the Indian Diplomatic mission and were thus repatriated on 28<sup>th</sup> July 2016 with 'caution' that during the course of investigations, if required, they will have to come forth, failing which actions for arrest via Interpol shall be initiated. Charles Ogada was remanded in custody for further interrogation.

In spite of Police action, following the true teachings of Sathya Sai Baba ("Forgiveness and Peace") - the Chairman of Zone 9A urged all the above-named persons to return to the true teachings of Sathya Sai Baba and to STOP false propoganda and the disgraceful activities being conducted in the name of Sathya Sai Baba wrongly.
